
2004 WI Farm Service Agency Imagery Programs

Overview: The USDA Farm Service Agency acquires digital imagery on a yearly basis during the cropping season for spot checking reported acreage of crops and updating farm records. 2004 NAIP (National Agriculture Imagery Program)

Overview: NAIP is a national program intended to replace FSA's 35 mm slide program. This imagery is being acquired for Wisconsin counties in 2004 with digitized farm and track field boundaries (common land unit). True color, orthorectified imagery

Timing: Imagery acquired between June 20th and August 30th 2004

Resolution: 2 m.

Accuracy: +/- 3% when compared to a Mosaicked Digital Orthophoto Quadrangle

Overview: The WI FSA State Office contracted to obtain imagery for non-NAIP counties in 2004. Characteristics:

True color, semi-rectified imagery – Center point of image registered to the predominant UTM Zone.

Timing: Imagery acquired between June 20th and August 30th, 2004

Resolution: 0.85 m.

Projection: Predominant UTM Zone (15 or 16 in WI) by county

Format: 4.5 sq mile tiles, .JPEG format

Accuracy: +/- 250 ft when compared to a Mosaicked Digital Orthophoto Quadrangle
